Jindal suspends deadlines for court proceedings by Associated Press

BATON ROUGE - Gov. Bobby Jindal on Friday issued an executive order that suspends all deadlines in legal, administrative and regulatory state court proceedings until next week.

Jindal, in the order, says since Hurricane Gustav struck the state there are extreme challenges to communication, which has hindered citizens' attempts to exercise their rights to effectively pursue or defend court claims.

In addition, he says Gustav has rendered several court houses and state facilities inoperable.

As a result, Jindal says all court deadlines are suspended until Sept. 12.

The suspension is retroactive to Aug. 29. •
